APPLICATION

To be considered for the scholarship, you must:

- 1. Be a Northern California resident and
- 2. Be enrolled in an institution for post-secondary education (ie; college, university, technical school).

Scholarships will be awarded on the basis of the following criteria:

- 1. Satisfactory completion of academic programs.
- 2. History of commitment to the South Asian community of Northern California.
- 3. Leadership potential in the South Asian community of Northern California.
- 4. Financial need.

Generally, community service and leadership potential will be given more weight and may be shown through past activities. Financial need may be demonstrated with various types of <u>credible</u> information, such as eligibility for financial aid.

Application Materials

The following materials must be submitted together:

- 1. Evidence of enrollment in an institution for post-secondary education (i.e., college, university, technical school).
- 2. Evidence of residency (enrollment for education in Northern California is sufficient for proof of residency).
- 3. A written personal statement, not to exceed two pages (double-spaced, size 10 12 font) in length. This statement must also include your name, address, email, and telephone number. The statement must be signed and dated. Generally, the Scholarship Committee is interested in employment experience and ambitions, community and campus activities, and unusual life experiences. If you feel you have overcome any form of hardship (financial, educational, physical, etc.,) you are encouraged to discuss the experience in your statement. Feel free to be creative and innovative in your approach to the personal statement.

- 4. Current résumé.
- 5. <u>Credible</u> financial information may be submitted if the applicant feels that he/she is in financial need. A summary financial statement and/or a copy of a student financial aid form is preferred.
- 6. Two letters of recommendation from separate individuals that are not related to the applicant. Letters should be written within the last six months and include the name, address, telephone number and email address of the recommending individual.
- 7. Completed Applicant Certification Form (see last page of this document).

Application Evaluation

The IVACC Scholarship Committee will evaluate each scholarship application and will select the scholarship recipients in its sole discretion. Scholarship Committee members will not participate in the evaluation of applicants to whom they are related. To facilitate the decision making process, the Committee may, in its discretion, require a personal interview with any or all scholarship applicants.

Application Deadline and Submission

The Application deadline is November 22, 2011.

Applications must be postmarked, emailed or received by the deadline date. Late application materials will not be considered unless authorized by the Scholarship Committee.
